95 KGGO'S "DARK STAR ORCHESTRA" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KGGO ("Station"), 4143 109th Street, Urbandale, Iowa 50322, during available business hours Monday through Friday, on the Station website www.kggo.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **95 KGGO's "DARK STAR ORCHESTRA"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - Contest Period. The Contest entry period will begin at 5:00 PM CT on Friday February 28, 2025 and will run from 12:00 AM CT until 11:59 PM CT on Sunday, March 2, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter.
- 4. <u>Text: Listen to the Station during the Contest Period. When the Station announces the Contest keyword, entrant must send a text message with the keyword spelled correctly to 515-809-9595 during the Contest Period. All entries must be received by 11:59 PM CT on March 2, 2025 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.</u>
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the

required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. The approximate retail value ("ARV") of each prize is Seventy Dollars (\$70 US).

- 7. Entry Conditions and Release. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
